## Re: Do not promote the NGO Bill - which is harmful to civil society in Israel

On Wednesday May 25, 2016 a hearing will take place in the Constitution, Law and Justice Committee regarding the bill and the requirement to disclose donations from a foreign political entity. The bill in question was promoted by the government under the guise of promoting transparency; however the true purpose of the bill is to mark out certain organizations as illegitimate and to impose disproportionate restrictions upon them, that would harm their activities.

It is well known that the law already imposes extensive obligations on NGOs to disclose their funding sources, with increased obligations regarding the disclosure of donations from foreign countries. This is despite the fact that foreign countries donate significant amounts of money to all areas of life in Israel.

This bill seeks to extend disclosure requirements, even though this is unnecessary, whilst imposing disproportionate limitations on the activities of certain organizations which would reduce their effectiveness. If that were not enough, the proposal discriminates between organizations by distinguishing between disclosure requirements for private donations and grants from foreign entities; even though the public interest requires equal disclosure and transparency about all of an organization's funding sources.

We believe that these arguments, however poignant, should be clarified in the public sphere; and not via laws that limit people's ability to express opinions or act. The delegitimization and vilification that is inherent in this legislation, disrupts the activity of civil society organizations, and discourages others from being part of the essential and legitimate public discourse in Israel.

Civil society organizations, including the organizations that the bill was formulated to target, play a vital role in promoting the voices and rights of the disadvantaged and providing assistance to those communities. The employees and volunteers of these organizations are fulfilling their civic right and duty to participate actively in public debate and the democratic process. This legislation will harm these extensive activities, which are being conducted with great concern for Israeli society; will erode democratic principles and universal values; and limit the freedom of expression and association in Israel. The harm that this bill is expected to cause for organizations and activists will hurt us all.
